## 8. Departmental Reports

# a. Village Manager's Report – Susan Phillips

The major construction phase for the golf course was started in June with twelve holes open for play. Tennis has seen a decline in revenues this year to date. The May Occupancy Tax showed an increase of 18% in comparison to May 2024. The summer Grillin' & Chillin' Events will continue every Wednesday this summer through Labor Day. The Avery Couty Commissioners have voted to delay the County revaluation until 2027, due to the damage caused by Helene.

# b. Police Chief's Monthly Report - Chief Casey Turbyfill

The July 4<sup>th</sup> Independence Day holiday was a great success for the Village and our public safety efforts. Our officers have been busy over the past month, patrolling the Village streets, conducting business walk-throughs, and conducting foot patrols. Warnings and state citations have been issued for speeding violations.

## c. Public Works Director's Monthly Report – Bill Daniels

Line striping has been completed on the roads. I anticipate having the paving finished before fall sets in. We have nearly finished the ditch cleaning project. This has been a very extensive and time-consuming task involving completely grading and cleaning out the surface and banks of the ditches using an excavator and skid steer. Dail Golf, our contractor on site performing the repairs, began pouring the concrete liners into the bunkers this week and will focus on preparing the remaining sand traps.
